ANNOUNCEMENT

It is in continuation of Advertisement No. 18 of 2025, published on 08.08.2025 for 255 posts of Assistant District Attorney (Group-B) in the Prosecution Department, Haryana. The syllabus for the advertised posts was issued vide announcement dated 08.08.2025. Some candidates had filed writ petitions in the Hon'ble High Court against the syllabus prescribed by the Commission. These writ petitions were disposed of vide order dated 17.10.2025 and the announcement dated 08.08.2025 and Advertisement No. 18 of 2025 dated 08.08.2025 were quashed. Said order was challenged by the Commission by filing LPA No. 3171 of 2025 and 6 other appeals in connected cases. These appeals have been disposed of by the Hon'ble High Court vide order dated 23.04.2026 by modifying the impugned judgment dated 17.10.2025 of the learned Single Bench, permitting the Commission to proceed with the recruitment by conducting a three phase/tier recruitment process. It has been directed that: -

The first phase i.e. the Screening Test, would consist of the objective type multiple choice questions with a minimum 50% questions from the field of law while remaining questions would be from the topics/syllabus specified in the announcement/advertisement dated 08.08.2025 as referred to above. The second and third phase of recruitment i.e. the Subject Knowledge Test and Interview shall be as per the patterned examination and will remain unaltered. In addition, since the Screening Test is only qualifying in nature, the Commission shall call candidates upto ten times the number of the advertised posts to participate in the second phase i.e. the Subject Knowledge Test.

16. *It is made clear that the aforesaid modification in the recruitment process is confined exclusively to the post of Assistant District Attorney and that this suggestion/modification shall not be treated as a precedent for any other recruitment process."*

In view of the above, the candidates who had applied in response to Advertisement No. 18 of 2025 are informed that the Screening Test for the posts of Assistant

District Attorney (Group-B) in the Prosecution Department, Haryana would be held on **21.06.2026 (Sunday)**.

The syllabus of the Screening Test is given as under: -

- a) General Science.
- b) Current Events of National and International Importance.
- c) History of India.
- d) Indian and World Geography.
- e) Indian Culture, Indian Polity and Indian Economy.
- f) General Mental Ability (Reasoning and Analytical Abilities).
- g) Basic numeracy (numbers and their relations, order of magnitude etc. Class X level). Data interpretation (charts, graphs, tables, data sufficiency etc. Class X level).
- h) Haryana GK - History, Geography, Polity, Economy, Culture etc.
- i) Civil Law
 - i) Code of Civil Procedure
 - ii) Bharatiya Sakshya Adhiniyam, 2023
 - iii) Indian Contract Act
 - iv) Indian Partnership Act
 - v) Sale of Goods Act
 - vi) Hindu Law
 - vii) Mohammadan Law and Customary Law.
- j) Criminal Law
 - i) Bharatiya Nyaya Sanhita (BNS) 2023
 - ii) Bharatiya Nagarik Suraksha Sanhita (BNSS) 2023
 - iii) Bharatiya Sakshya Adhiniyam, 2023

It is informed that as directed by Hon'ble High Court a minimum 50% questions would be from the field of law (i.e from the topics mentioned at point (i) and (j) above) and remaining questions would be from the topics mentioned at (a) to (h) above.

Further in compliance of directions issued by Hon'ble High Court, candidates TEN times the number of advertised posts along with bracketed candidates, if any,

will be called for the Subject Knowledge Test, provided that they have secured the minimum cutoff marks of 25%.

Other terms & Conditions, as mentioned in the advertisement No. 18 /2025 and announcement dated 08.08.2025 will remain unchanged.
